### WHAT IS THIS PRODUCT?

#### Objectives:

The fund aims to generate long-term capital appreciation.

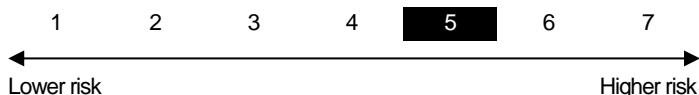
The fund invests primarily in securities issued by companies listed in Hong Kong, the People's Republic of China, Singapore, the United States or the United Kingdom which are principally engaged in health related industries in China, including pharmaceuticals, bio-technology, medical devices, healthcare providers, hospitals, nursing homes and environmental protection. Such securities will include equity securities, equity-related securities, American Depositary Receipts, Global Depositary Receipts, debt securities (such as debentures, fixed or floating rate corporate or sovereign notes and bonds) of investment grade or below investment grade and money market instruments. (such as treasury bills, certificates of deposit, commercial paper and bankers acceptances). The fund will not invest in other open-ended collective investment schemes and will at all times invest more than 50% of its net asset value directly in equity securities. Subject to the equity securities quota, the fund may also invest in cash and in real estate investment trusts (REITs) which are listed on the Shanghai Stock Exchange, the Shenzhen Stock Exchange, the Singapore Stock Exchange or on the Hong Kong Stock Exchange provided that they do not affect the ability of the fund to meet its liquidity obligations. The fund may invest indirectly in the A-share market by purchasing equity linked securities which will constitute transferable securities which will be listed, traded or dealt on a recognised exchange or, unlisted securities. In the case of unlisted securities, such investment shall not exceed 10% of the fund's net asset value. The fund may invest in have direct access to A-shares listed on the Shanghai Stock Exchange via the Shanghai-Hong Kong Stock Connect scheme and/or the Shenzhen Stock Exchange via the Shenzhen- Hong Kong Stock Connect scheme. Exposure to A-shares through the Connect Schemes will not be more than 50% of the fund's net asset value.

The fund is considered to be actively managed in reference to the Hang Seng Healthcare Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

#### Intended Retail Investor:

Individuals with investment experience who seek exposure to Chinese equities relating to the healthcare industry and aim to achieve long term capital appreciation.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the fund to pay you.**

**Be aware of risks.** Market price risk: The fund's assets consist principally of equities. The values of these instruments are determined by market forces and there is accordingly a risk that market prices can change in a way that is adverse to the fund's performance. A number of investment restrictions as set out in the prospectus are adopted to limit the exposure of the fund to negative changes in the price of any individual financial asset.

Currency risk: The fund is exposed to currency risk as its assets and liabilities may be denominated in a currency other than the functional currency of the fund, the USD. The fluctuations in the rate of exchange between the currency in which the asset or liability is denominated and the functional currency could result in an appreciation or depreciation in the fair value of that asset.

Interest rate risk: The majority of the funds' financial assets and financial liabilities are non-interest bearing. Therefore, the fund is not subject to significant amounts of risk due to fluctuations in the prevailing levels of market interest rates;

Credit risk: The fund is exposed to limited credit risk as the Depository holds all assets on behalf of the fund in a segregated account. The fund's financial assets are equity securities. All transactions are settled and paid for upon delivery of stock and by using approved brokers. The risk of default is considered minimal.

Liquidity risk: The fund invests the majority of its assets in securities and other instruments that are traded regularly and which are considered to be realisable under normal market conditions.
